DEPARTMENT OF TOURISM**NOTICE 514 OF 2020****AMENDMENT OF DIRECTIONS ON RISK ADJUSTED STRATEGY FOR TOURISM FACILITIES, SERVICES AND PRODUCTS ISSUED IN TERMS OF REGULATION 4(10) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002), GUIDELINES TO PREVENT AND COMBAT THE SPREAD OF COVID-19**

I, Ms Mmamoloko Kubayi-Ngubane, the Minister of Tourism, hereby, in terms of regulation 4(10) of the Regulations made in terms of section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), and published in the Government *Gazette* No.43258, Government Notice No. R480 of 29 April 2020 as amended, amend Government Notice No. 356 published in Government *Gazette* No. 43487 of 29 June 2020 as amended by General Notice No. 414 of 6 August 2020 published in Government *Gazette* No. 43585 and General Notice No. 452 published in Government *Gazette* No.43653 of 25 August 2020, as set out in the Schedule.

Schedule

Definitions

1. In this Schedule unless the context indicates otherwise—

“**Directions**” means the Directions published in Government *Gazette* No.43487, Government Notice No. 356 of 29 June 2020, as amended by General Notice No. 414 of 6 August 2020 published in Government *Gazette* No. 43585 and General Notice No. 452 of 25 August 2020 published in Government *Gazette* No.43653.

Amendment of paragraph 11 of the Directions

2. Paragraph 11.1 of the Directions is amended by the substitution for paragraph 11.1 of the following paragraph:

“11.1 Attendance at a venue for a wedding, exhibition or any other function is limited to 50 percent of the capacity of the venue with a maximum of 250 persons at an indoor venue and a maximum of 500 persons at an outdoor venue: Provided that persons participating through electronic platforms are not included in these limitations and all hygienic conditions and physical distancing measures are adhered to, in order to limit the exposure of persons to COVID-19.”.

Addition of paragraph 13 in the Directions

3. The Directions are amended by the addition of the following paragraph after paragraph 12:

“**Certificate of Occupancy**”

13. The owner or operator of a restaurant, a conferences, meetings, weddings, exhibitions or functions venue, a hotel, lodge, bed and breakfast, time share facility, resort, guest house or a casino must display a certificate of occupancy which sets out the maximum number of persons the facility may hold.”.

COMMENCEMENT

4. These Directions come into operation on the date of publication in the *Government Gazette*.
